NOTE : (i) The duration for each Paper shall be of 3 hours.

(ii) 40% in each paper shall be pass marks for the exam*. Provided that the percentage fixed as above shall be relaxed by 5% for the candidates belonging to the Scheduled Castes and Scheduled Tribes.

(iii) Senior secondary Level will be the standard of the language paper.

(iv) The pattern of question paper will be Objective Type.

(v) There shall be 150 questions for each paper.

(vi) There shall be negative marking. 1/3 marks shall be deducted for each wrong answer.
